## Exhibition Terms and market regulation (GTC)

### 1) Participation conditions

Authorized for sale are only watches, jewelry and precious stones of all kinds, including accessories and literature. It is strictly prohibited to offer reproductions and fakes. The offer or exhibition of any kind of prohibited goods leads to the exclusion of the event. Each exhibitor must be registered under his own name and is obliged to keep his name or company name visible disclosed at his stand. Each stand must be manned during the duration of the event. It is not allowed to build up or dismantle the stand while the visiting time of the public.

**Before the opening of the market (11:00 clock) only registered exhibitors are eligible for admission.**

**Stand construction: from 8.00 to 10.00 a.m. / Dismantling: from 17.00 to 18.00 p.m.**

### 2) House rules

In addition to the market order and the Conditions of the organizer, the house rules of the respective event location is completely valid. It is not allowed to cause any changes or damages by screws, nails, etc., made to the premises or its facilities. In case of violations of these regulation the promoter reserves the right to take appropriate measures against the person who caused the damage.

### 3) Liability

The Promoter shall not be liable for any loss, property damage or bodily injury. Damage incurred by arms' length, debt must be followed by the exhibitor / dealer. The organizers are not in the case of force majeure or in the presence of him entitled Indebted reasons to postpone the event, shorten or cancel. The exhibitor / dealer has in these cases not entitled to damages, especially not on the loss he incurred hereby economic.

### 4) Booth rental

The booth rent is due as payment for prior confirmation from the organizer to pay; Bank transfer or check, payable at least 14 days before the event. When non-compliance with the payment deadline the organizer has the right to dispose of a rented booth in other ways. In any case, the stand rent is due before the opening event. Appear at non-there is no right to a refund of the advance, the organizer is also entitled to recover from the non-published exhibitor / dealer as the outstanding rent.

**5) The exhibitor / dealer confirms** that he shall comply with all applicable legal and regulatory requirements for him.

### 6) Parking

Parking is allowed only on the designated parking area. After unloading the vehicles that dealers are to be parked there. Under no circumstances may Emergency walkways for fire or emergency vehicles are blocked. Note on signs to look for.

### 7) Jurisdiction

### 8) Final provisions

With registration, each exhibitor / dealer market order and Exhibition Conditions of content and legally binding. Should one or more provisions of these Exhibition conditions, the regulations, ineffective, the validity of this otherwise unaffected. All notices and statements are to be submitted to the organizers need to be in written form.

The instructions of the organizer or his representative must be obeyed. The domestic authority exercises the traditional pub. In all other respects all legal and regulatory requirements.
